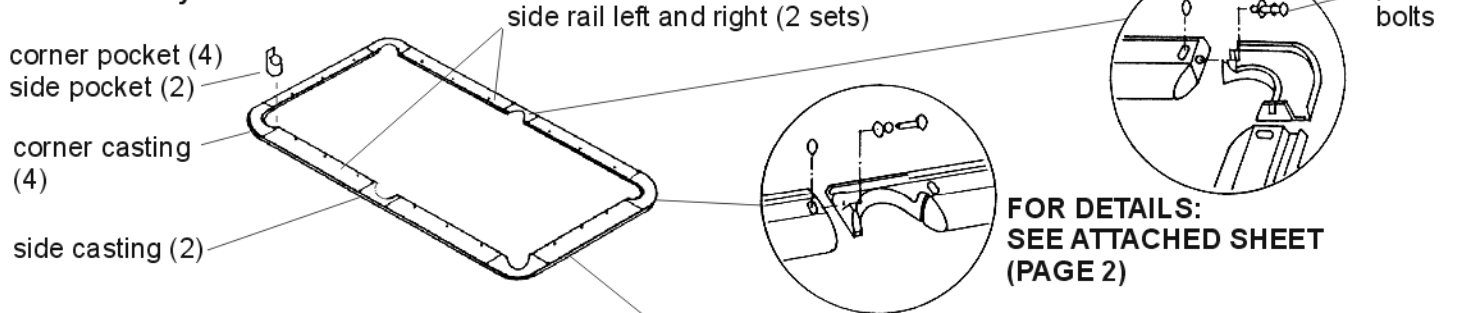
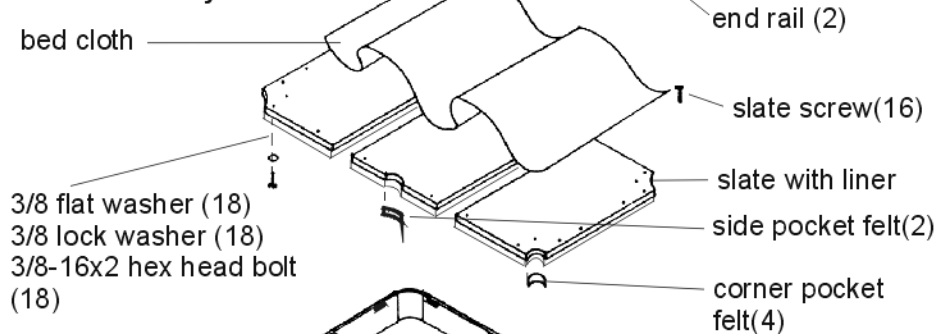

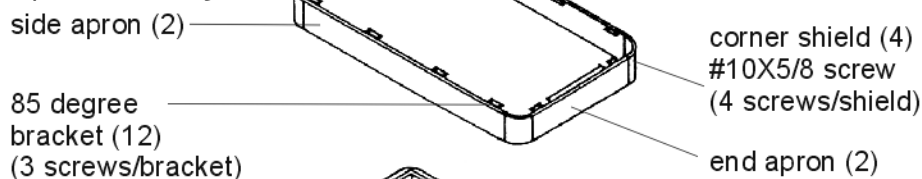
Rail Assembly

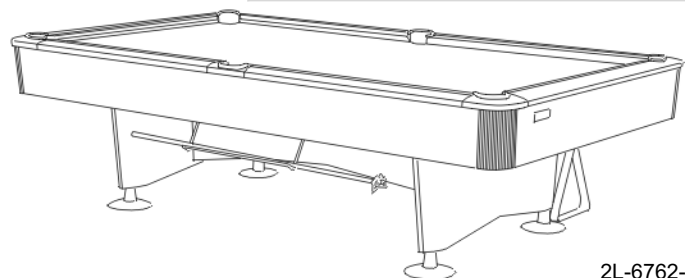


Leg Assembly



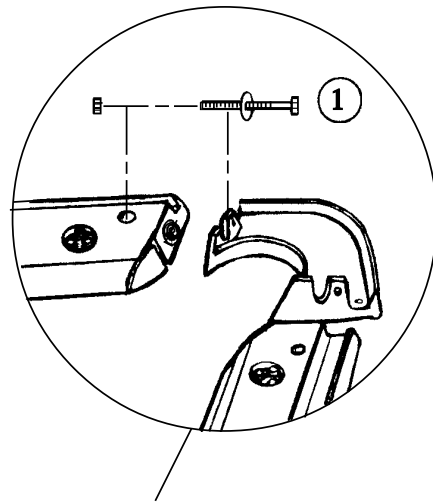
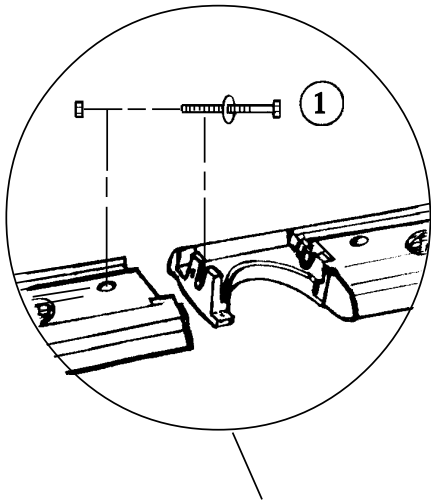
INSTRUCTIONS:

- 1) ASSEMBLE MAIN FRAME.
NOTE: Top of frame identified with painted marks. Orient frame members Accordingly.
- 2) ASSEMBLE PEDESTAL LEGS TO THE SPREADER BAR AND ATTACH TO MAIN FRAME.
- 3) INSTALL SLATE ON MAIN FRAME.
- 4) LEVEL THE TABLE AS NEEDED.
- 5) CLOTH BED.
- 6) INSTALL CORNER AND SIDE POCKET FELT.
- 7) CLOTH RAILS AND MOUNT TO CASTINGS.
- 8) MOUNT RAIL CASTING ASSEMBLY TO TABLE.
- 9) ATTACH APRON ASSEMBLY.
- 10) INSTALL BRIDGE AND TRIANGLE HOLDER.



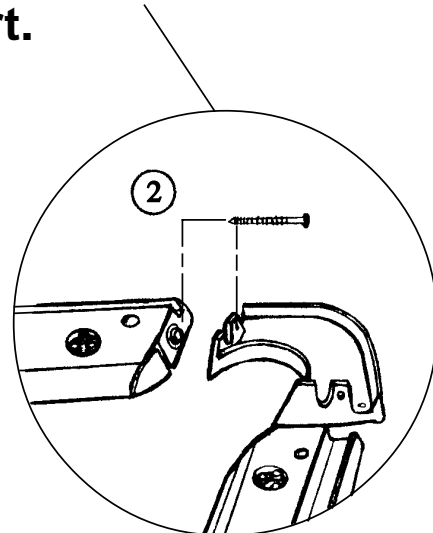
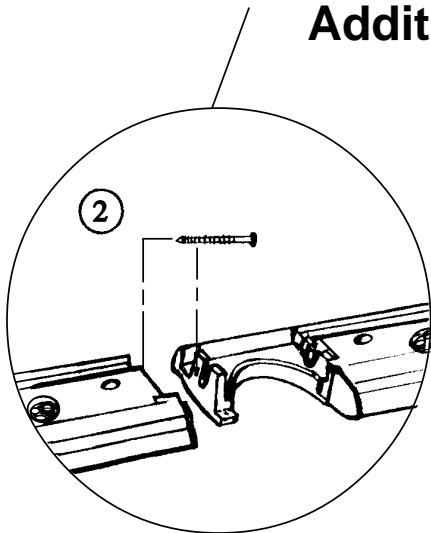

1. Adjust and Secure Castings as Required.

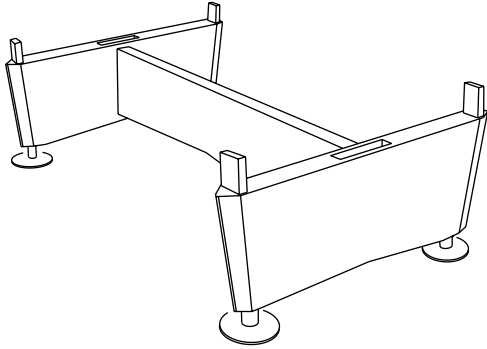
2. Install 1-1/2" Wood Screws for Additional Support.



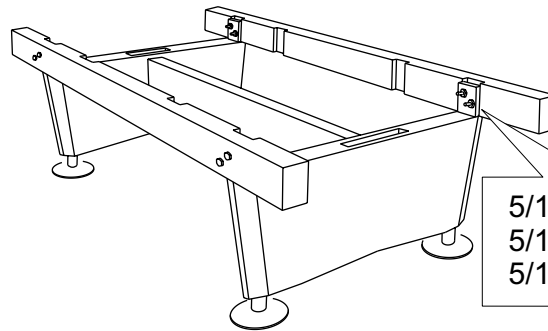

MAIN FRAME ASSEMBLY

1) Assemble two pedestals to spreader bar, insert leg levelers.



2) Place side beam on outside of pedestals (2 bolts in 4 places) and attach loosely as shown.
Note: Top of frame marked with white notch. Orient frame members accordingly.

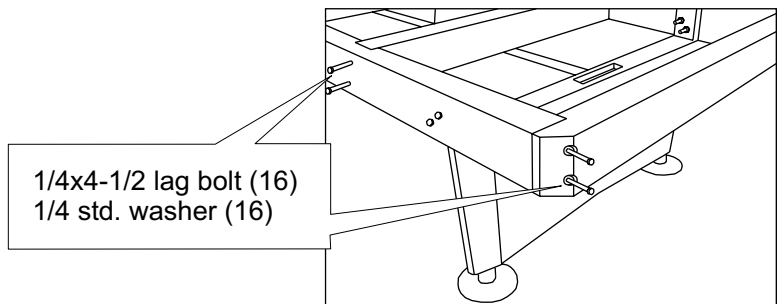


5/16-18x5 hex bolt (8)
 5/16 std. washer (16)
 5/16-8 hex nut (8)

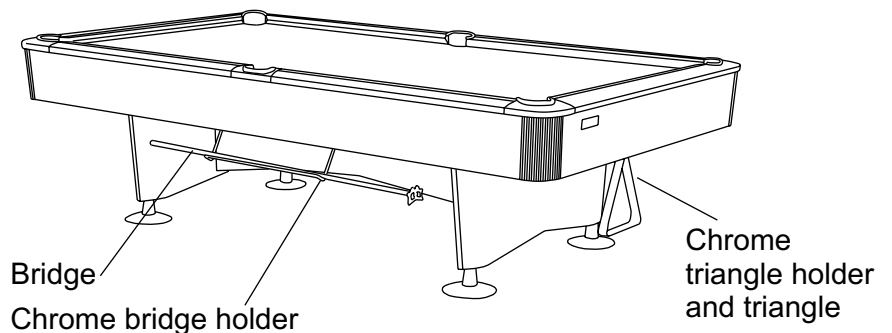
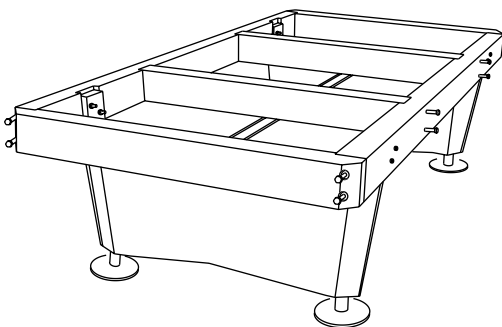
3) Insert cross beam into notches on side beams and attach loosely as shown.

4) Attach end beams to ends of frame sides loosely as shown.

5) Square beams to one another and tighten all beam bolts and leg mounting bolts. Level frame using leg levelers.
